I I, Gregory Newby, hereby declare as follows:

2 My name is Gregory Newby. reside in Efland, North Carolina. 3 2. I am the Volunteer CEO of the Project Gutenberg Literary Archive 4 Foundation, a 501(c)(3) nonprofit corporation organized under the laws of 5 Mississippi. Since 1997, I have also been an Assistant Professor with the School 6 of Information and Library Science at the University of North Carolina Chapel 7 Hill. Between 1991 and 1997, I served as an Assistant Professor, Graduate School 8 of Library and Information Science, University of Illinois at Urbana-Champaign. 9 Prior to that, I was an instructor and adjunct faculty member at Syracuse University in Syracuse, New York. I have published dozens of articles and taught 10 numerous courses on information sciences and internet issues. received a Ph.D. in 12 Information Transfer from Syracuse University in 1993, an M.A. in Communications from SUNY Albany in 1988, and a B.A. in Communications and 13 14 Psychology from SUNY Albany in 1987. My complete vitae can be found at 15 http://www.ils.unc.edu/gbnewby/vita.html.

16 Project Gutenberg is the oldest information provider on the Internet, 3 having been founded by Michael S. Hart in 197 . Although the "internet" at the 17 18 time included only a few computers tied together in a system known as ARPANet, 19 it was clear to Mr. Hart even then that anything that can be entered into a computer 20 can be reproduced indefinitely. By making use of this principle, it was clear to him 21 that everyone in the world, or even not in this world (given satellite transmission), 22 could have a copy of every book that has ever been entered into a computer. In order to make this dream a reality, he founded Project Gutenberg to begin entering 23 24 public domain works into computers and make them easily available to the public 25 and to charge nothing for the eBooks.

4. It is the aim of Project Gutenberg to make information, books and
other materials available free of charge to the general public in a general form that
the vast majority of computers, programs and people can easily read, use, quote,

around the world, most of whom insist on using markup languages that limit users
to certain reading and searching programs. In 1971, Mr. Hart began this project by
typing the U.S. Declaration of Independence into a computer at the University of
Illinois Material Research Laboratory and making it available to other computer
users. Since then, an international group of volunteers has been entering public
domain works of light literature, heavy literature, reference and scientific materials
into computers and making them available to the general public via the Net.

5. Today, Project Gutenberg has co-ordinated the efforts of thousands of
volunteers world-wide. These volunteers enter public domain works into
computers, format these works as simple eBooks so that they can be used by the
widest variety of computers, including the new "Palm Powered" PDAs, and make
these eBooks available to the general public over the Internet through various
servers located around the world on every continent. These are all operated by
volunteers on their own time and expense.

16 Since its inception in 197, Project Gutenberg has made over 4,000 6. 17 eBooks available. expect that number will grow to at least 5,000 by July 4, 2002. 8 The vast majority of these are works in the public domain, while the remainder have been authorized by copyright owners for Project Gutenberg distribution as 19 eBooks. Thanks to the work of Project Gutenberg volunteers, we published over 20 21 1,250 eBooks over the calendar year ending January 7th, 2002, and we have started 22 the new year on a blazing schedule that would yield 2,002 new eBooks in the next 23 52 weeks, if we can continue.

16	to the efforts of Project Gutenberg and many others, well over 10,000 eBooks are
17	now available on the Internet. This number should pass 20,000 in February, 2002.
18	9. Because most Project Gutenberg eBooks are public domain works,
19	those who download them are entitled to do anything they like with them. You can
20	also quote from them, abridge them, or create new works based on them. You can
21	re-post them on your site, print them, distribute them, convert them to other
22	formats. In fact, because the original goal of Project Gutenberg was to make
23	information and literature available to the general public at a cost truly "too cheap
24	to meter," redistribution of eBooks is encouraged. Although it may be expensive
25	and cumbersome to collect thousands of public domain works in paper formats,
26	Project Gutenberg hopes to reduce those costs so every person with a computer can
27	have free, convenient access to a vast library of public domain works. The average
28	new computer today costs under \$700, and 100 gigabyte drives are between \$100

and \$200 depending the brand and place of purchase. With gigabytes approaching
 \$1 each, that means the entire Project Gutenberg collection wouldn't cost even \$10
 to store, and perhaps another \$10 to make backups on a CD writer. Sometime in
 2002 you should be able to put 5,000 Project Gutenberg eBooks on one of these
 new computers by using up just \$10 of your drive space.

6 In an effort to ensure that Project Gutenberg eBooks can be read by 10 7 the widest variety of computers, they are made available in what has become known as "Plain Vanilla ASCII," meaning that our files use only the basic 8 9 character set standardized by the American Standard Code for Information 10 Interchange: the same kind of character you read on a normal printed page. Italics, 1 underlines, and bolds have been capitalized. We also make many of our files 12 available in various other formats, but the plain files seem to be the favorites. At 13 least one of our files is NOT in plain text format, at the request of the authors.

14 11. Although eBooks are distributed by Project Gutenberg from
15 computers that use file transfer protocol (FTP/HTTP servers), eBook files are
16 suitable for distribution through many computer file-sharing technologies. For
17 example, eBooks may be sent as email attachments. Others have reformatted
18 eBooks in Hypertext Markup Language (HTML) and a variety of other formats,
19 and made them available on the World Wide Web.

12. Any technology that makes it easier and cheaper for individuals to
redistribute eBooks over the Internet helps achieve Project Gutenberg's goals of
making public domain information freely available to the general public. I
understand that numerous public domain Project Gutenberg eBooks are being
made available by users of Morpheus, Kazaa, Gnutella, Grokster and similar
software products and welcome this widespread sharing of public domain works.
